Please note:

- BOOTH AND SPACE LOCATIONS ARE ON A FIRST-COME/FIRST-PAY FIRST-SERVED BASIS. Applications without payments by the deadline will not be considered.
- THERE WILL BE NO PICK-UP OF APPLICATIONS AND PAYMENTS.
- Payments can be in the form of cash, check, or money order payable to the "Philippine Independence Day Foundation" or "PIDF". We require a driver's license number and expiration date written on the memo section.
- Should you wish to deliver your Application and payment personally instead of mailing, please contact Fred Docdocil at (310) 619-8101.

For your information, the following are prohibited at the venue: ALCOHOLIC BEVERAGES, CIGARS, CIGARETTES, E-CIGARETTES, VAPE, MARIJUANA, CONFETTI EGGS, WEAPONS, SILLY STRINGS, ANY TYPE OF SPRAY PAINTS, AND ANIMALS, WHETHER DOMESTIC OR EXOTIC.

NOTE: A business license is **NOT REQUIRED** when participating in City-sponsored events like the Philippine Independence Day Celebration. However, food vendors must still secure Health Permits from the County Health Department once notified that booth application is approved. Health Permits must be submitted to PIDF not later than April 30, 2019.

Waiver, Release, Hold Harmless, Agreement Not to Sue and Indemnification

I, _____, (“individual”) [on behalf of _____ (“Exhibitor”), and as a bona fide agent of Exhibitor duly authorized to execute this Waiver, Release, Hold Harmless, Agreement Not to Sue and Indemnification agreement (“Agreement”) on behalf of Exhibitor] (individual and Exhibitor hereinafter referred to as “Signatory,” and the term “Signatory” includes Signatory’s officers, officials, employees, agents and volunteers), seek acceptance by the City of Carson of an application to rent a booth at and thereby participate in/at Philippine Independence Day Celebration (“Event”) on June 6, 2020 (“Date”).

Signatory understands that accidents and injuries can arise out of the Event; knowing the risks, nevertheless, and in consideration of the acceptance of an application to rent a booth at the Event on the Date, Signatory hereby waives, releases and discharges any and all claims for damages for death, personal injury, or property damage which Signatory may have, or which hereafter accrue to Signatory, against the City of Carson, its elected and appointed officers, officials, employees, agents and volunteers (collectively “City”), from and against any and all liability arising out of or connected in any way with Signatory’s participation in the Event, even though that liability may arise out of negligence or carelessness on the part of City. It is further understood and agreed that this Agreement is to be binding on Signatory’s heirs and assigns.

Signatory hereby grants City the right to photograph or video-record Signatory during or in connection with the Event, and to use Signatory’s photographed or video-recorded likeness, and any image, silhouette, or reproduction of the voice or appearance of Signatory taken during or in connection with the Event (“Likeness”), for any purpose, including publicity and promotion of City and its events, and creation or production of materials in any form for such purpose, with no claim of entitlement to any license fee or royalty of any kind from City. Signatory hereby waives any right to the intellectual property of Signatory’s Likeness. The rights granted by Signatory hereunder shall not expire.

Signatory further agrees to indemnify, defend and hold harmless City from and against any and all claims, liabilities, losses, damages, expenses, costs (including without limitation costs and fees of litigation) of every nature (including, but not limited to, property damage, bodily injury, or death), whether imposed by law or otherwise, sustained or alleged to be sustained by any person or entity (whether they be members of the public visiting the Event, employees of the City, other exhibitors at the Event, or otherwise), occurring at, arising from, or connected with Signatory’s preparation, presentation or participation at the Event, Signatory’s actions, inactions, or use of facilities at the Event, or any equipment, machinery or items displayed or used by the Signatory for the Event, except for such claim, liability, loss, damage, expense, or cost which was caused by the sole negligence or willful misconduct of the City.
